Statement of Issues Addressed By the Revised Policy

The Department of Student Support Services recommends readopting Policy 2352. This policy requires the reporting of all injuries and medical emergencies that occur on Board of Education property or at school sponsored activities. The department is recommending that no substantive revisions be made to Policy 2352 ADMINISTRATION: Administrative Operations: Accidents/Medical Emergencies
