**Policy Analysis for
Board of Education Policy 4113
Certification**

Statement of Issues or Questions Addressed:

Board of Education Policy 4113, which has not been revised since its establishment in 1968, states that the superintendent, assistant superintendent, supervisors, principals, and teachers be certified. Certification requirements are covered under COMAR, MSDE regulations and the Office of Personnel Procedures Manual. Board Policy 4113 and the Superintendent's Rule 4113 are no longer needed and may be deleted.

Cost Analysis and Fiscal Impact on School System:

No fiscal impact is anticipated by the deletion of this policy.
