**POLICY ANALYSIS FOR
BOARD OF EDUCATION POLICY 3510
OPERATIONS**

Statement of Issues or Questions Addressed

In accordance with Board of Education Policy and Superintendent's Rule 8130, Policy 3510 is scheduled for review in school year 2011-2012. Policy 3510 articulates the Board's commitment to the efficient and effective operation of the school plant. Staff is recommending that the policy be revised to: (1) include a philosophy statement that details the Board's commitment to the operations of the school plant and its connection to student achievement; (2) conform to the Policy Review Committee's editing conventions.

I. PHILOSOPHY

[The operation of the school plant shall be the responsibility of the Department of Physical Facilities.]

II. IMPLEMENTATION

THE BOARD DIRECTS THE SUPERINTENDENT TO INCLUDE IN THE ANNUAL OPERATING BUDGET THE necessary personnel, equipment, and supplies FOR THE OPERATION OF THE SCHOOL PLANT [shall be provided in the annual operating budget to enable this vital function to proceed in the most efficient and economical manner].
