**POLICY ANALYSIS FOR
BOARD OF EDUCATION POLICY 3530
SAFETY AND SECURITY**

Statement of Issues or Questions Addressed

In accordance with Board of Education Policy and Superintendent's Rule 8130, Policy 3530 is scheduled for review in school year 2012-2013. Policy 3530 outlines the standards required by the Board to ensure the safety and security of the school system's physical plant facilities. Staff is recommending that that policy be revised to: (1) include a philosophy statement recognizing the Board's responsibility to operate and maintain the physical plants in a safe and secure manner; (2) include an implementation section; (3) conform with the Policy Review Committee's editing conventions.

Safety and Security

I. PHILOSOPHY

- A. THE BOARD OF EDUCATION OF BALTIMORE COUNTY (BOARD) RECOGNIZES ITS RESPONSIBILITY TO OPERATE AND MAINTAIN ITS PHYSICAL PLANTS IN A SAFE AND SECURE MANNER AND TO ENSURE COMPLIANCE WITH APPLICABLE FEDERAL, STATE, AND OTHER CODES AND REGULATIONS.

II. STANDARDS

- A. Appropriate procedures shall be established to provide for the safe operation and maintenance of the school plant.
- B. Boiler systems shall be properly maintained; inspected annually by the insurance underwriter; and operated by certified personnel.
- C. School facilities shall be accessible to the Baltimore County Fire Department and Health Department in ACCORDANCE [compliance] with applicable STATE AND COUNTY regulations and codeS [requirements].
- D. Buildings and grounds shall be maintained in a condition that shall minimize the potential of injury to anyone using these facilities.

III. IMPLEMENTATION

- A. THE BOARD DIRECTS THE SUPERINTENDENT TO IMPLEMENT THIS POLICY.
